Amendments proposed. In the 8th line of the 2d page, after the word "charitable" insert the word "uses." At the end of the same line insert the following proviso: "Provided nevertheless, that the said corporation or body politic shall not, at any one time, hold or possess property, real, personal or mixed, exceeding in total value the sum of twenty thousand pounds current money." At the end of the 2d line from the bottom of the same page insert the following clause: "And be it enacted, that all appointments of officers for said society heretofore made by the members thereof in their private capacities shall respectively continue and be in full force until the time specified by this act for the first election of officers for said body corporate."
