The bill to confirm the divisions made in the city of Washington of the estate of John Davidson, deceased, and for other purposes, was read the second time by especial order, passed, and sent to the senate by the clerk.

The bill to revive an act of assembly therein mentioned was read the second time, passed, and sent to the senate by the clerk.
