The Jurors for their Ma<sup>ties</sup> being sworn upon the holy Evangelists at a grand Jury held for the body of this County the 1st day of March last past do present and find that John Hammond of this County Blame about the month of May Anno Domini 1689. at the Indian Towne called Abington upon the River did without Commission ransack the wood and thorn and there did take up and to his plantation carry away two young Bay hogs a Mare belonging to the sd Edmund Howard of this County and the sd hogs did unjustly and unlawfully break and sell as his own proper goods without either the knowledge or consent of the sd Edmund Howard, the said Hammond having no claim property or interest in the said Bay hogs but wilfully, maliciously and feloniously did the sd hogs steal, and dispose of out of this Province, the sd hogs being of the value of two hundred thirty and nine pounds of le Baue to the great damage and detriment of the sd Edmund Howard, and evil example of their Ma<sup>ties</sup> good people of this Province, and agtl. the publick peace, therefore their Ma<sup>ties</sup> Attorney and Judgment may be entered agtl. the sd John Hammond as
