In witness whereof I have hereunto set and affixed my hand and seal this 20. of April an^o 93 Pom. 1687.

The Condition of this Present Obligation that if the above bounden Joseph Freeman his heirs, Executors or Admors. or Assignes, shall satisfy Content and pay or cause to be well and truly satisfied contented and paid unto the above named Francis Goubrin, his heirs Executors, Admors. or Assignes or lawfull attorney the full and just sum or quantity of Twenty thousand seven hundred and twenty pounds of good round Merchants Tobacco in Cash at some one Court next ensuing within the County aforesaid, that then this present Obligation to be void and of none effect, otherwise to stand and remain in full force power and virtue.
