Add the following section:

Section 17. And Be it enacted. That the President and Directors are individually liable for all contracts until one-half of the capital stock shall be subscribed for and paid in.

Which was read and adopted, and the bill

BY THE SENATE,

January 18, 1866.

Gentlemen of the House of Delegates:

We propose, with the concurrence of your Honorable Body,
