At the first general election of Delegates to the General Assembly, after the adoption of this Constitution, four Commissioners shall be elected as hereinafter provided, who shall be styled "Commissioners of Public Works," and who shall exercise a diligent and faithful supervision of all Public Works, in which the State may be interested as stockholder or creditor, and shall represent the State in all meetings of the Stockholders, and shall appoint the Directors in every Rail Road or Canal Company, in which the State has the constitutional power to appoint Directors.
