

Art. IV, § 41: Register of Wills term is changed from six to four years.

Art. V, § 1: Attorney general—day of election—"1867" replaced by "1958".

Art. V, § 7: State's attorney—day of election—"1867" replaced by "1958".

Art. VII, § 1: County commissioners—date of election—"1867" replaced by "1958"—term reduced from six to four years.

Art. VII, § 2: Surveyor—election day—"1867" replaced by "1958"—term lengthened from two to four years.

Art. VII, § 6: Relating to office of wreck master in Worcester County—whole section stricken.

Art. IX, § 3: Relating to "existing Militia Law" was stricken.

Art. X: Relating to labor and agriculture was stricken.

Art. XII, § 2: Clauses specifically referring to the Chesapeake & Ohio Canal Co. were stricken. The sentence declaring CH. 359, Acts of 1867 null and void was stricken.

Art. XIV: Amendments to the Constitution—"1877" replaced by "1970".

Art. XV, § 1: Clause at end of section which limited salary of any office created by constitution (unless constitution provided otherwise) to \$3,000 was stricken.

Art. XV, § 3: Provided for continuance in office of present officeholders until successors qualified—whole section stricken.

Art. XV, § 7: Election day to be the Tuesday after the first Monday in month of November—clause which followed, providing for the exceptions, was stricken.

Art. XV, § 8: Notice of election by sheriffs—whole section stricken.

Art. XVII, § 3: Terms of all state officers elected are four years—exceptions were stricken.

Art. XVII, § 4: Terms of officers appointed by governor or county commissioner shall be fixed by law—exceptions stricken.
