<p>Election procedure: Registration of voters.</p>	<p>shall vote in any election district, or ward, in which he does not reside (except in the case provided for in this Article), or shall, at the same election, vote in more than one election district, or precinct, or shall vote, or offer to vote, in any name not his own, or in place of any other person of the same name, or shall vote in any county in which he does not reside.</p> <p>Sec. 5.
