SEC. 9. This act to continue three years, and unto the end Duration. of the next session of assembly which shall happen after the said three years.

Continued to 1803, and by November, 1803, and then renewed and continued in the annual continuance law thereafter.

NOVEMBER, 1779.—CHAPTER 10.

An Acr to explain the several acts of Assembly heretofore made relative to the enrolment of deeds.

See 1715, ch. 47, and the notes.

WHEREAS doubts have arisen in some of the courts of justice Preamble. of this state, whether the time limited by laws heretofore made for the enrolment of deeds and conveyances should be computed by lunar or calendar months, and the computation by calendar months being most agreeable to the common acceptation of the word month, and great inconvenience might arise to many of the inhabitants of this state by a different computation:

Sec. 2. Be it therefore enacted and declared, by the General Tobe Assembly of Maryland, That in all cases where the enrolment deemed calendar of deeds is directed by law to be made within six months from months. the day of the date of the same deeds, the said months shall be deemed and taken, and are hereby declared to be calendar months.

CHAPTER 25.

An Act for the regulation of Officers' Fees.

WHEREAS officers' fees can be rated, regulated and esta- Preamble. blished, by act of assembly only, and such an act is now expedient and necessary.

SEC. 2. Be it enacted, by the General Assembly of Maryland, Officers not That no officer or officers hereafter mentioned in this present to take greater fees act, their ministers, servants, or deputies, by reason or colour of than limithis or their office or offices, shall have, receive, or take, of any person or persons, directly or indirectly, any other or greater fees, which shall arise or become due after the commencement of this act, than are hereafter limited and allowed to the several
