SEC. 19. And be it enacted. That the governor and council shall, as soon as practicable after the first day of April next, proceed to fill up any and all vacancies which may be reported to them by the adjutant-general, among the commissioned officers of the third division, and the adjutant-general is hereby directed to make said report to the governor and council, on or before the day last aforesaid.

SEC. 21. And be it enacted. That so much of the act of eighteen hundred and twenty-three, chapter one hundred and eighty-eight, or of any other act as authorizes the second regiment of riflemen, the fifty-first regiment of infantry, and the twelfth regiment of cavalry, be, and the same is hereby repealed.

Inconsistent acte repealed.

SEC. 22. And be it enacted, That any clause, matter or thing in the act of December session, eighteen hundred and twentythree, chapter one hundred and eighty-eight, or in the supplement thereto, or in the several militia laws of this state, which shall be found inconsistent with, or repugnant to the provisions of this act, are hereby repealed, so far as relates to the city of Baltimore; Provided however, that whenever the militia of the city of Baltimore, or any part thereof, shall be called into actual service, they shall in all respects be subject to the like regulations and orders, as the other militia of the state.

Proviso.

Confined to Baltimore.

SEC. 23. And be it enacted, That nothing in this act shall be construed to extend to any part of the militia of this state, except within the limits of the city of Baltimore, nor shall it be City gaurds construed to impair the privileges of the Baltimore City Guards. so far as they are exempt from militia duty.
