CHANCERY.

The chancellor empowered to determine all disputes between the purchasers of confiscated property and the state, by making the attorney-general a party—April 1787, ch. 30, sec. 4, 244

To prescribe the penalty of appeal bonds, on application to remove suits by executors or administrators, on a statement of facts supported by affidavit or other proof—1793, ch. 75, sec. 2, 304

To prescribe the penalty of a bond to be executed, on application for an injunction to stay proceedings at law, with a security or securities to be approved by him, before such injunction is granted—1793, ch. 75, sec. 3, 304

The chancellor empowered to execute deeds to purchasers of confiscated property on sales made by governor and council—1802, ch. 100, sec. 11, 471
