

*Error.*

Reversioner shall have a writ of error. 9 Rich. 2, Ch. 3.

Judgments not to be reversed for error in places razed, &c. 8 Henry 6, Ch. 12, S. 1.

Defendant in error to have costs and damages. 3 Henry 7, Ch. 10; 19 Henry 7, Ch. 20.

Security shall be given in error after verdict in dower and ejectment. 16 and 17 Car. 2, Ch. 8, S. 3.

Death of a party after verdict, not error, if judgment be entered in two terms. 17 Car. 2, Ch. 8.

Costs on quashing writ of error. 4 Anne, Ch. 16, S. 25.

Writs of error amended. 5 George 1, Ch. 13.

*Escape.*

Debt shall lie for an escape of a person in execution. 13 Edward 1, Ch. 11.

Debt given for escape of prisoner in execution. 1 Rich. 2, Ch. 12.

Plea of fresh pursuit to be on oath. 8 and 9 William 3, Ch. 27, S. 6.

Prisoner in execution escaping, may be taken on a new *capias*. 8 and 9 William 3, Ch. 27, S. 7.

Escape warrants granted. 1 Anne, St. 2, Ch. 6; 5 Anne, Ch. 9.

*Escapes.*

Persons taken on escape warrants, to be kept where debtors are. 5 Anne, Ch. 9, S. 1.

Warrants on escapes may be executed on the Sunday. 5 Anne, Ch. 9, S. 3.

Action given for escape of prisoner in execution upon a decree in equity. 5 Anne, Ch. 9, S. 4.

*Evidence.*

What good evidence of death of lessee for life. 19 Car. 2, Ch. 6.

*Exceptions.*

If the justices refuse to allow an exception, they shall seal a bill of it on request. 13 Edward 1, St. 1, Ch. 31.

*Execution.*

After a year *sicere facias* necessary. 13 Edward 1, St. 1, Ch. 45.

A new execution shall go, on a prisoner's dying in execution. 21 James 1, Ch. 24.

Where it may be sued by administrator *de bonis non*. 17 Car. 2, Ch. 8.

Where, on trust lands. 29 Car. 2, Ch. 3, S. 10.

*Fieri facias* binds the property of goods, only from the day it is delivered to the sheriff. 29 Car. 2, Ch. 3, S. 16.

Where it shall go against the heir after alienation of lands descended. 3 William and Mary, Ch. 14, S. 5 and 6.

Landlord must be paid before a *fieri facias* is executed. 8 Anne, Ch. 14, S. 1.

*Executors.*

Where part of them may sell lands devised to be sold. 21 Henry 8, Ch. 4.

Person fraudulently obtaining goods to be charged as executor *de son tort*. 43 Elizabeth, Ch. 8, S. 2.

Administrator *de bonis non* may sue execution, on judgment obtained by executor. 17 Car. 2, Ch. 8.

*Exemplification.*

Where judgment shall not be reversed for error in record contrary to exemplification. 8 Henry 6, Ch. 12, S. 4.

*Felons and felony.*

Breaking prison felony, where prisoner is in custody for a felony. 1 Edward 2, St. 2.

*Feme covert.*

See baron and feme.

*Fieri facias.*

See execution.

*Forcible entry and detainer.*

Forcible and unlawful entries prohibited. 5 Richard 2, St. 1, Ch. 8.
