*Inland bills.*

*Insurance.*

Insurance on effects; interest or no interest, prohibited. 19 George 2, Ch. 37.

Re-assurance, except in cases of insolvency, &c. prohibited. 19 George 2, Ch. 37, S. 4.

Insured, to declare in writing on demand, what sums they have insured. 19 George 2, Ch. 37, S. 6.

Insurers permitted to bring money into court. 19 George 2, Ch. 37, S. 7.

*Intestate.*

*Joint tenants, and tenants in common.*

May bring waste. 13 Edward 1, St. 1, Ch. 22.
