The Governor appoints three members from 12 names submitted to him by the State Board of Agriculture. Not more than two members to be of the same political party. The Board issues licenses to all distributors of milk purchased from producers, and licenses to stores selling milk, to be consumed off the premises; also issues permits to producers producing milk within the State. All milk shipped into the State from other States becomes subject to the regulations of the Board the moment it comes to rest within the State. The general power conferred upon the Commission extends to the supervision, regulation, investigation and control of all matters pertaining to the production, transportation, processing, storage, distribution and sale of milk in the State of Maryland; and for the purpose of investigation, to conduct hearings, administer oaths, issue process and compel the attendance of witnesses. (Copies of the said law may be had by addressing the Board.)

The entire expense of the Commission must not exceed the tax imposed under the provisions of the Act.
