The function of this Commission is to carry forward the participation of the State as a member of the Council of State Governments; to encourage and assist the legislative, executive, administrative and judicial officials and employees of this State to develop and maintain friendly contact with officials and employees of the other States, of the Federal government and of local units of government; to endeavor to advance cooperation between this State and other units of government, whenever it deems it advisable to do so, formulating proposals for, and by facilitating, the adoption of compacts, the enactment of uniform or reciprocal statutes or administrative rules or regulations, cooperation of governmental officials and officers with one another and to take such other steps as it may deem advisable to assist in bringing the various governments in the United States into closer contact, and in developing the Council of State Governments for this purpose.
