The Department of Transportation was created by Chapter 526, Acts of 1970. The head of the Department is the Secretary of Transportation who is appointed by the Governor with the advice and consent of the Senate. The Secretary serves at the pleasure of the Governor and advises the Governor on all matters assigned to the Department of Transportation.

The Secretary of Transportation is responsible for the operation of the Department; for promulgating rules and regulations of his office; for all planning activities of the Department of Transportation, including the creation and promulgation of a State master plan for transportation; and for fostering economical and efficient transportation services throughout the State.

Additionally, the Secretary of Transportation is responsible for the budget of his office and the budgets of the boards, commissions, administrations and agencies within the jurisdiction of the Department of Transportation.

The Department of Transportation brings together under the direction of the Secretary five primary transportation agencies: the State Aviation Administration, the Maryland Port Administration, the Mass Transit Administration, the State Motor Vehicle Administration, and the State Highway Administration. Also providing the Secretary with advice, guidance and direction in a variety of transportation matters are the Maryland Airport Zoning Board, the Airport Zoning Commission, the Board of Airport Zoning Appeals, the Department of Transportation Board of Review, the Maryland Transportation Commission, and the State Roads Commission (Code 1957, 1971 Repl. Vol., Art. 41, secs. 207-208; 1969 Repl. Vol., 1970 Supp., Art. 94A).
