adequate service and protection from State-chartered financial institutions. The Commission consists of representatives of the general public, the banking industry, the business community, the State Bank Commissioner, the Deputy State Bank Commissioner, and the Speaker of the House of Delegates. The Commission is to report at a later date.
