The Governor appointed this Special Study Commission in 1973 by Executive Order to examine the problem of land use and to seek ways to strike a balance between preserving land reserves and those areas which need preservation and allowing an orderly planned growth and development. The Commission consists of members of the General Assembly, members of Boards of County Commissioners and County Councils, Planning and Zoning officers, and members of the general public concerned with the problem. The Commission is to present its recommendations to the 1974 Session of the General Assembly.
