Seeks to provide social justice without upheaval, promote racial harmony and serve as an advocate for the vulnerable—young, aged, poor and others. Organized into a number of task force committees in the areas of Health and Welfare, Education, Legislation and Criminal Justice, Employment and Economy and Housing.

BALTIMORE SYMPHONY ORCHESTRA, 120 W. Mount Royal Avenue, Baltimore 21201; Joseph Leavitt, General Man-

ager. The orchestra furnishes educational, cultural and artistic services for the benefit of the entire population of the State. The orchestra plays approximately 285 concerts per year throughout the State for all age groups. Nearly 500,000 persons attended concerts during 1975-76 season.

STAR SPANGLED BANNER FLAG HOUSE ASSOCIATION, INC., 844 East Pratt Street, Baltimore 21202; National Historic Landmark. Herbert E. Witz, President; Mrs. Hugh MacD Martin, Director. Serves to perpetuate the Old Flag House as a shrine to our early founders. Many original mementos of the Pickersgill and Key families are on exhibition as well as interesting relics of the War of 1812 period. Publishes newsletter in addition to various pamphlets, brochures, maps, and folders of historical significance.

MARYLAND STATE FIREMEN'S ASSOCIATION, J. Francis Fatkin, Secretary, Route 1, Box 702, Frostburg 21532. The funds appropriated represent the State's contribution to pensions which may be paid to volunteer firemen or to their families in certain instances and to provide educational benefits to the children of deceased or disabled volunteer firemen (Code 1957, 1971 Repl.
