The Department of Juvenile Services, created by Chapter 126, Acts of 1966, is the central coordinating administrative agency for juvenile investigation, probation and after-care services, and for State juvenile diagnostic, training, detention, and rehabilitation institutions. The Director is appointed by the Governor upon the recommendation of the Secretary of Health and Mental Hygiene. The Deputy Director is appointed by the Director with the approval of the Secretary.

The Administration certifies for operation within the State the public and private institutions, organizations and agencies which deal with the Department in the area of juvenile delinquency.

The Administration supervises two State training schools. This includes development and promulgation of regulations, standards of care, and policies affecting operation and management of programs serving children in these schools.

The Administration also supervises the State's four Forestry Camps for delinquent
