The Governor appointed this special commission in 1965 at the request of the General Assembly to make a comprehensive study and review of the criminal laws of the State, criminal procedures and the administration of criminal justice.

The Commission submitted its interim report on October 16, 1971, to the Governor and the Legislature. Volumes containing a Report and Part I of a Proposed Criminal Code (June, 1972) and a Report and Part II of a Proposed Criminal Code (September, 1973) were circulated among the

Bench, Bar and interested public for study and comment. The Commission then submitted a revised draft of a bill and commentary, published as Legislative Council Item No. 6-13 (November 25, 1974). The draft is currently under study by committees of the Legislature (J.R. No. 22, Acts of 1965).
