One of the members must be a County Commissioner (Ch. 918, Acts of 1941). This Board was continued by the county charter as the Prince George's County Hospital Advisory Board. A member of the County Council serves as a member of the Board, ex officio.

¹⁴⁶ Appointed by the County Executive with the consent of the County Council.

¹⁴⁷ Composed of 11 members originally appointed by the Board of County Commissioners for 1-year terms. The Chairman is to be appointed annually by the Board of County Commissioners. Subsequent terms of the members of the Commission will be for 3 years. The County Executive now makes the appointments subject to County Council approval.

¹⁴⁸ Appointed by the County Executive with County Council approval.

¹⁴⁹ Composed of the County Health Officer, the Chief of Police, and five citizens including a veterinarian and a representative of the local humane organization. Members serve two year terms and are appointed by the County Executive with County Council confirmation. The County Executive designates the Chairman.

¹⁵⁰ Appointed by the County Executive with County Council approval.

¹⁵¹ Composed of the members of the Maryland-National Capital Park and Planning Commission from Prince George's County; members are appointed by the County Executive with County Council approval for 4-year terms.
