The Legislative Policy Committee was established by Chapter 362, Acts of 1976 to replace the Legislative Council created by Chapter 62, Acts of 1939. The Committee consists of twenty members, ten from the Senate and ten from the House of Delegates. The President of the Senate, the Chairmen of the Budget and Taxation, Constitutional and Public Law, Economic Affairs, Finance, and Judicial Proceedings committees, and the Minority Floor Leader are members from the Senate. The President appoints three additional members to be representative of the various areas of the State. The Speaker of the House of Delegates, the Chairmen of the Appropriations, Constitutional and Administrative Law, Economic Matters, Environmental Matters, Judiciary, and Ways and Means committees,
