Chapter 973 - 1978

AN ACT authorizing the State Treasurer, subject to approval by the Board of Public Works, and as provided, to make and sell short-term notes in the name of the State in anticipation of the collection of taxes, or other revenues, including the proceeds from the sale of bonds, to meet temporary deficiencies subject to certain conditions.

Chapter 974 - 1978

AN ACT giving the General Assembly the authority, except as the Constitution provides otherwise for any office, to provide by law a temporary replacement for any elected or appointed officer of the State who is unavailable to perform the duties of his office because he has become unable or is or will be absent; and providing for certain codification.
