The Maryland Blue Sky Advisory Committee was created by Chapter 1, Acts of 1962. The Committee meets when called by the Securities Commissioner to advise the Commissioner on any and all matters pertaining to the administration of the Maryland Securities Act, particularly on the adoption, amendment, or repeal of rules, regulations, or forms (Code Corporations and Associations Article, sec. 11-202).

The Committee consists of six members appointed by the Governor for staggered terms of three years each. The Committee functions without compensation and has no staff. It selects its own chairperson.
