

In Baltimore City and in each county there is a local department of social services whose director administers these public assistance activities subject to the supervision, direction, and control of the Income Maintenance Administration.

Six major units are included in the Administration: the Offices of Public Assistance, Administrative Services, Program Integrity, Program Support, Corrective Action, and Legislative and Audit Liaison. The Administration also includes Fair Hearings, Quality Control, and Special Investigations units.

The Executive Director is appointed by the Secretary of Human Resources.
