The University of Maryland Medical System Corporation was established by Chapter 288, Acts of 1984, as a private, nonprofit corporation. The Corporation is responsible for patient care, medical education, community health services, and emergency medical treatment provided by the medical systems of the University of Maryland.

The Corporation is governed by a Board of Directors consisting of seven non-voting, *ex officio* members and twenty-one voting members appointed by the Governor for five-year terms. Appointed members include minority representatives, three regents of the University of Maryland, one senator and one delegate, at least one person knowledgeable in the administration of hospitals, and at least one member of the Community

Advisory Council. The Board elects the Chief Executive Officer of the Corporation.

The Chairman of the Board of Directors appoints a Community Advisory Council, whose members serve three-year terms. The Committee advises the Board on services offered by the Corporation that are of importance to the community (Code Education Article, secs. 13-1B-01 through 13-1B-13).

The Maryland Veterans Commission was first established by Chapter 344, Acts of 1924. It was reorganized by Chapter 803, Acts of 1945, Chapter 310, Acts of 1966, and Chapters 370 and 617, Acts of 1971. In 1977 it was removed from the jurisdiction of the Department of Human Resources and made an independent agency (Chapter 895, Acts of 1977).

The Commission has jurisdiction over matters relating to veterans' cemeteries in Maryland, including establishment, acquisition, supervision and control, and requirements for eligibility for burial. The Commission maintains a permanent registry of graves of all persons who served in the military or naval forces of the country in time of war and who are buried in Maryland (Code State Government Article, secs. 9-904 through 9-914).

The Commission is composed of twenty-three Maryland veterans appointed by the Governor for seven-year terms. The chairperson of the Maryland Veterans Home Commission serves as a member,
