The Governor originally appointed this committee in 1971 to establish a safety program for State employees who drive State and private motor vehicles to conduct official State business. The Governor reauthorized the Committee in 1985 (Executive Order 01.01.1985.21).

The Committee advises the Governor on matters relating to the safe operation and maintenance of the State's motor vehicle fleet. This advisory role includes recommending changes in rules and regulations for the use of State agency motor vehicles. The Committee also coordinates fleet safety activities by State agencies. In addition, the Committee is to develop a comprehensive plan for the prevention of accidents, an accident review information system, and a driver improvement program.

The Council recommends annual food and nutrition priorities, as well as changes in programs and budgets. In addition, the Council considers methods to identify and monitor the nutritional needs of Marylanders and to foster public and private coordination of efforts to meet those needs.
