In December 1985, the Governor created the State Advisory Council on Nutrition (Executive Order 01.01.1985.35). The Council serves as an advisory board to the Governor and the Governor's Cabinet Council on the Coordination of Food and Nutrition Services. The Council makes recommendations for a comprehensive State policy on food and nutrition and for public and private programs that prevent and treat malnutrition and poor dietary habits. Food and nutrition programs and program plans come under Council review.

Appointed to two-year terms by the Governor, the Council has fourteen members.

The Governor appointed the Task Force on Private Sector Day Care Initiatives in January 1986. The Task Force is to explore and promote the development of day care services and assistance by the private sector. In pursuing this work, the Task Force will examine the role of the Day Care Facilities Guarantee Loan Fund, available through the Department of Economic and Employment Development. The Task Force also will consider incentives that might encourage more business participation; examples of success and failure in private sector day care services; and the role of government in enhancing corporate participation.

The Task Force will submit its report by June 1987.
