In September 1985, the Governor created the Task Force on Real Property Closing Costs. The Task Force was asked to consider ways to reduce real estate settlement costs that may discourage buyers, including corporate real property buyers who need to relocate in Maryland. The Task Force compared Maryland closing costs with those of other states and also compared costs in each jurisdiction within Maryland.

After analyzing the impact of these costs on State economic development and on the individual purchaser, the Task Force reported its recommendations in January 1986.

At the request of the General Assembly, the Governor created the Task Force on Regional Library Resource Center Programs in August 1986 (Joint Resolution no. 33, Acts of 1986).

Since 1973, regional library resource centers have been established in Southern Maryland, the Eastern Shore, and Western Maryland. The Task Force was to determine if the mandated services
