In December 1984, the Governor appointed the Maryland Shock Trauma Negotiating Team. The Maryland Team met with its counterpart from the District of Columbia to find better ways to coordinate shock trauma services for citizens of Montgomery and Prince George's counties, Southern Maryland, and the District of Columbia. The negotiators resolved differences with regard to treatment protocols, such as staffing levels and care philosophies; reimbursement issues, particularly those related to the Medicaid program and Maryland's all payer hospital reimbursement system; and victim transport, especially offsite transport by helicopter.

In January 1987, the Team concluded its work.
