The United States Attorney is appointed to a four-year term by the President of the United States with the advice and consent of the U.S. Senate. The U.S. Attorney serves at the pleasure of the President. Assistant Attorneys are chosen by the U.S. Attorney and appointed by the U.S. Attorney General for indefinite terms.
