The Maryland Environmental Trust was created in 1967 to conserve, improve, stimulate, and perpetuate the aesthetic, natural, scenic, and cultural aspects of the Maryland environment (Chapter 648, Acts of 1967). The Trust also promotes appreciation of the environment and continued interest in its care.

The Trust seeks donations of conservation easements to the State on certain lands to preserve the land from development. By 1986, the Trust had secured 111 conservation easements on 21,000 acres.

The Trust consists of fifteen trustees. Three serve ex officio. The remaining twelve trustees each year elect three of their own successors for four-year terms. The Trust selects the Director (Code Natural Resources Article, secs. 3-201 through 3-211).
