The Police Training Commission was created in 1966 to improve law enforcement by raising standards of training and education for police (Chapter 286, Acts of 1966).

Subject to the authority of the Secretary of Public Safety and Correctional Services, the Commission prescribes standards for and certifies schools that offer police and security training. It may revoke a school's certification for cause. The Commission sets minimum qualifications for instructors and certifies qualified instructors for approved training schools.
