

The Maryland Juvenile Justice Advisory Council was established in 1984 as an independent unit within the Department of Health and Mental Hygiene (Executive Order 01.01.1984.08). In 1987, the Council was placed under the Juvenile Services Agency (Executive Order 01.01.1987.21). The Council became part of the Governor's Office in 1988 (Executive Order 01.01.1988.01).

The Council advises the Governor and appropriate State agencies on all matters pertaining to the juvenile justice system and delinquency prevention.

The Council is the designated State agency to receive formula grant funds under provisions of the federal Juvenile Justice and Delinquency Prevention Act of 1974 (P.L. 93-415), as amended by the Juvenile Justice Amendments of 1980 (P.L. 96-509). The Council's responsibilities include developing an annual plan (in accordance with the federal Act), establishing grant procedures, and making grant awards. Fiscal administration of grant funds is provided by the Juvenile Services Agency.

The Council consists of from fifteen to thirty-three members appointed by the Governor to three-year terms. The Governor designates the chairperson.

In September 1985, the Governor appointed the Maryland Coordinating Committee for the Martin Luther King, Jr. Holiday. The Committee develops commemorative and educational programs in tribute to Dr. Martin Luther King, Jr. (1929-1968). Dr. King led the civil rights movement which brought an end to the system of segregation in this country. He was awarded the Nobel Peace Prize in 1964.

The birthday of Dr. King, January 15th, has been observed as a State holiday in Maryland since 1975 (Chapter 440, Acts of 1974). Its observance as a national holiday began in 1986.

In July 1986, the Governor created the Korean War Memorial Commission at the request of the General Assembly (Joint Resolution no. 3, Acts of 1985). The Commission is to make recommendations regarding the design, construction, and placement of a memorial to Marylanders who served in the Korean War. Dedication of the memorial is planned for Veterans Day, November 11, 1989.

Additionally, the Commission will compile a list of Marylanders who died in or are still declared missing-in-action from the Korean War.
