The Task Force charge was to determine the need for legislation requiring installation of security devices and equipment at twenty-four hour retail establishments, such as service stations, convenience stores, and restaurants. The Task Force also evaluated the scope of such legislation, its specificity with regard to particular security devices and equipment, and its effects on service to the public.

The Governor's Task Force on Self-Insurance was created by the Governor in May 1987. The Task Force examined the effectiveness of self-insurance as an alternative to traditional insurance requirements. The Task Force considered the proper State response to ensure viable and efficient self-insurance programs, including administrative or legislative reforms; the feasibility and appropriateness of centrally administering all self-insurance programs; and criteria for evaluating self-insurance programs. A final report was submitted to the Governor on February 26, 1988.
