Twenty-one are voting members appointed to fiveyear terms by the Governor. Appointed members include minority representatives, three regents of the University of Maryland, one senator and one delegate, at least one person knowledgeable in the administration of hospitals, and at least one member of the Community Advisory Council. The Board elects the Chief Executive Officer of the Corporation.

The Chairman of the Board of Directors appoints a Community Advisory Council, whose members serve three-year terms. The Committee advises the Board on services offered by the Corporation that are of importance to the community (Code Education Article, secs. 13-1B-01 through 13-1B-13).

Origins of the Maryland Veterans Commission can be traced to 1924 when the State created a relief fund for disabled veterans of World War I (Chapter 344, Acts of 1924). From 1929, the Veterans Relief Commission administered the fund (Chapter 134, Acts of 1929). The Commission was renamed the Maryland Veterans Commission in 1935 (Chapter 481, Acts of 1935). The Commission became part of the Department of Employment and Social Services (later named Department of Human Resources) in 1971 (Chapters 370 and 617, Acts of 1971). In 1977, the Commission was removed from the jurisdiction of the Department of Human Resources and made an independent agency (Chapter 895, Acts of 1977).

The Maryland Veterans Commission serves Maryland veterans and their dependents. The Commission assists in the development, preparation, submission, and approval of claims covering the full
