

Care Services Division. In 1989, it was restructured as the Field Services Division.

The Division provides intake, probation and aftercare services for delinquent youth. Through intake services, the Division decides for each juvenile whether court proceedings are appropriate. The Division also recommends to the court that adjudicated delinquents be placed on probation, in a day program, in a residential program, or committed to the Charles H. Hickey, Jr. School. The Division supervises delinquent youth during probation or placement and monitors them after their release from a residential facility or the Hickey School.

The Division coordinates and monitors departmental programs for education, health services, volunteers, foster grandparents, and substance abuse. The Division also operates the Arthur G. Murphy, Sr. Youth Service Center.

The Arthur G. Murphy, Sr. Youth Services Center opened in 1973 as an alternative nonresidential education program for delinquent youth. Baltimore City Delegate Arthur G. Murphy, Sr., had long been a champion of education and vocational opportunities for inner city youth. Following his untimely death, the Youth Services Center was renamed in his honor and stands as a memorial to his dedication and concerns for youth.

Serving youth ages 16 to 18, the Center provides academic and vocational instruction, as well as training in job readiness skills. The program offers students the opportunity to acquire General Equivalency Diplomas (G.E.D.) and to become employed.

The Facilities and Residential Services Division originated as the Institution and Detention Services Division, created in 1987. The Division received its present name in 1989. The Division oversees supervision of the Charles H. Hickey, Jr. School, three community-based residential facilities in Baltimore City, and five youth centers for young people committed by the court. The Division also operates five detention centers and a community detention program for juveniles awaiting trial or disposition. In addition, the Division is responsible for transporting youth between court and State facilities.

The Charles H. Hickey, Jr. School originated in 1850 as the House of Refuge (Chapter 374, Acts of 1849). In 1910, it was renamed Maryland School for Boys and, in 1918, became Maryland Training School for Boys (Chapter 300, Acts of 1918). The School adopted its present name in 1985 (Chapter 245, Acts of 1985).

The School serves as a detention center for youth awaiting trial and as a training school for young people committed by the court. The School cares for and treats delinquent youth between the ages of 15 and 17 (Code 1957, Art. 83C, sec. 2-117).
