Under the Child Support Enforcement Administration, restructured in 1991 as the Office of Policy and Central Operations.

DIVISION OF AFDC POLICY

Formerly under the Income Maintenance Administration, Division functions were reorganized in 1993 as part of the Division of Policy.

DIVISION OF FOOD STAMP POLICY

Formerly under the Income Maintenance Administration, Division functions were reorganized in 1993 as part of the Division of Policy.

DIVISION OF MEDICAL ASSISTANCE

Formerly under the Income Maintenance Administration, Division functions were reorganized in 1993 as part of the Division of Policy.

DIVISION OF SPECIAL ASSISTANCE POLICY

Formerly under the Income Maintenance Administration, Division functions were reorganized in 1993 as part of the Division of Policy.

FIELD OPERATIONS OFFICE

Under the Child Support Enforcement Administration, in 1990, renamed as the Office of Program Management and, in 1991, as the Office of Program Development and Management.

FOSTER FAMILY RESOURCE DEVELOPMENT

Renamed in 1993 as Resource Recruitment within the Office of Child Placement Resources of the Social Services Administration.

OFFICE OF ADMINISTRATIVE SUPPORT SERVICES

Under the Social Services Administration, the Office was reorganized in 1991 as the Office of Executive Management and Support Services.

OFFICE OF CHILD WELFARE SERVICES

Under the Social Services Administration, reformed as the Office of Child Placement Resources in 1991.

OFFICE OF CORRECTIVE ACTION

Under the Income Maintenance Administration, in 1992, the Office ceased to operate; its functions were assigned to the Division of Management Support under the Office of Quality Assurance.

OFFICE OF FAMILY & CHILDREN'S DEVELOPMENT SERVICES

Under the Social Services Administration, reorganized in 1991 as the Office of Family and Children's Services.

OFFICE OF FEDERAL PROGRAM REIMBURSEMENT

Under the Social Services Administration, renamed as the Office of Federal Funding Initiatives in 1991.

OFFICE OF FIELD OPERATIONS

Under the Income Maintenance Administration, reorganized as the Office of Quality Assurance in 1992.

OFFICE OF GOVERNMENT RELATIONS

The Office was reorganized in 1993 as the Office of Policy and Legislation within the Office of the Secretary.

OFFICE OF INTERAGENCY PROGRAM DEVELOPMENT

Under the Social Services Administration, the Office of Interagency Program Development was reorganized in 1993 as the Office of Special Programs.

OFFICE OF POLICY & CENTRAL OPERATIONS

Under the Child Support Enforcement Administration, abolished in 1992 and its functions assigned to the Office of Interstate Operations, the Office of Intercepts and Adjustments, and the Office of Program Initiatives.

OFFICE OF POLICY DEVELOPMENT

Under the Income Maintenance Administration, renamed as the Office of Policy Administration in 1993.

OFFICE OF PROGRAM DEVELOPMENT & MANAGEMENT

Under the Child Support Enforcement Administration, abolished in 1992 and its duties assigned to the Office of Service Delivery and the Office of Program Initiatives.

OFFICE OF PROGRAM INTEGRITY

Under the Income Maintenance Administration, the Office was reorganized in 1992 as the Division of Special Investigations under the Office of Quality Assurance.

OFFICE OF PROGRAM MANAGEMENT

Under the Child Support Administration, renamed the Office of Program Development and Management in 1991.

OFFICE OF PROGRAM SUPPORT

Under the Income Maintenance Administration, reorganized as the Office of Program Innovations in 1992.

OFFICE OF PROGRAM SUPPORT

Under the Social Services Administration, renamed as the Office of Program Review and Monitoring in 1991.

OFFICE OF PUBLIC ASSISTANCE

Under the Income Maintenance Administration, the Office was reorganized in 1992 as the Office of Policy Development.
