The Revenue Administration Division was created in July 1993, when the revenue divisions of the Comptroller of the Treasury were reorganized

from a tax-type to a functional basis. The Division receives and processes tax returns and payments from individuals, corporations, businesses, employers, and fiduciaries. Part of the revenue received is distributed to Maryland's county and municipal governments.

The Division is composed of six sections: Administration; Returns Processing; Revenue Accounting; System Applications Control; Taxpayer Accounting; and Taxpayer Services.
