Under the Technical and Regulatory Services Administration, in 1995 renamed Computer Modeling and Information Management Systems Program.

**MONITORING PROGRAM**

Under the Technical and Regulatory Services Administration, renamed Field Operations Program in 1995.

**MULTI-MEDIA TECHNICAL SUPPORT PROGRAM**

In 1995, combined with Emergency Operations and Enforcement Coordination Program to form Emergency Operations and Technical Support Program under the Technical and Regulatory Services Administration.

**NEW SOURCE PERMITS DIVISION**

Under the Air Quality Permits Program, renamed Chemical and Mineral Permits Division in 1995.

**NONPOINT-SOURCE ASSESSMENT & POLICY PROGRAM**

Under the Chesapeake Bay and Watershed Management Administration, renamed Watershed Management Program in 1994.

**OFFICE OF COMMUNITY ASSISTANCE**

In 1995, renamed Public Information and Community Assistance.

**OFFICE OF EMERGENCY & ENFORCEMENT COORDINATION**

Under the Radiological Health Program in the Air and Radiation Management Administration, renamed Emergency Response and Enforcement Coordination in 1994.

**OPERATIONS MANAGEMENT DIVISION**

Under the Water Management Administration, reorganized as the Office of Administrative Services in 1995.

**PERMITS & TECHNICAL SUPPORT DIVISION**

Under the Oil Control Program, renamed Permits and Underground Storage Tank Loan Division in 1995.

**PLANNING & RESOURCE MANAGEMENT PROGRAM**

Under the Waste Management Administration, renamed Regulatory and Technical Assistance Program in 1995.

**PRETREATMENT DIVISION**

Under the Water and Wastewater Permits Program, Division functions were reassigned to the Industrial Permits Division in 1996.

**PROGRAM DEVELOPMENT & FINANCE OFFICE**

Under the Water Management Administration, restructured as the Office of Program Development and Business Services in 1995.

**RADIATION MATERIALS COMPLIANCE DIVISION**

Under the Radiological Health Program, reorganized in 1995 as the Radioactive Materials Licensing, Compliance and Safeguards Division.

**RADON OFFICE**

Formerly under the Air and Radiation Management Administration, discontinued in Sept. 1995 due to budget cuts.

**REGULATIONS & AUTHORIZATION DIVISION**

Under the Waste Management Administration, renamed Regulations and Permitting Division in 1995.

**RESOURCE CONSERVATION RECOVERY ACT PERMITTING DIVISION**

Under the Waste Management Administration, functions of this division were assumed by the Regulations and Permitting Division in 1995.

**RISK MANAGEMENT DIVISION**

Under Administrative and Employee Services Administration, renamed the Safety Services and Facilities Management Division in 1995.

**SEWAGE SLUDGE COMPLIANCE DIVISION**

Under the Waste Management Administration, its functions were reassigned to the Field Operations and Compliance Division and the Design and Certification Division in 1995.

**SOLID WASTE COMPLIANCE DIVISION**

Under the Solid Waste Program, renamed Field Operations and Compliance Division in 1995.

**STORMWATER GENERAL PERMITS DIVISION**

Under the Water Management Administration, in 1995 transferred from the Nonpoint Source Permits Program to the Inspection and Compliance Program and renamed the Resource Planning and Utility Division.

**STRATEGIC PLANNING & POLICY COORDINATION**

Under the Deputy Secretary, functions reorganized in 1995 as Policy Coordination.

**TRACKING & TOXICS INVENTORY DIVISION**

Under the Waste Management Administration, reorganized in 1995 as the Tracking and Hazardous Materials Transportation Division. At the same time, Toxics Inventory became part of the Computer Systems Support Division in the Technical and Regulatory Services Administration.

**WATER QUALITY CERTIFICATION DIVISION**

Formerly under the Nonpoint-Source Permits Program, Division functions transferred to the Wetlands and Waterways Program of the Water Management Administration in 1995.

**WATER QUALITY PROGRAM**

In 1995, transferred from the Water Management Administration to the Technical and Regulatory Services Administration and reorganized as the Environmental Risk Assessment Program.

**WATERSHED MANAGEMENT PROGRAM**

Under the Technical and Regulatory Services Administration, reorganized as the Multi-Media Technical Support Program in 1995.
