The Advisory Committee on Graduate Medical Education was formed in 1995 by the Health Services Cost Review Commission to help the Department of Fiscal Services study the financing of graduate medical education (Chapter 499, Acts of 1995). On December 1, 1995, the Committee reported to the Senate Finance Committee and the House Environmental Matters Committee on a plan to distribute equitably the reasonable costs of graduate medical education.

CENTER FOR PROFESSIONAL EDUCATION & HEALTH SERVICES

Under the AIDS Administration, renamed Center for Professional Education and Patient Services in 1995

CHILDREN, YOUTH & FAMILIES DIVISION

Under the Alcohol and Drug Abuse Administration, merged with the Special Populations Division in 1994.

DIVISION OF AUDIT COORDINATION & MANAGEMENT ANALYSIS

Under the Fiscal Services Administration, renamed Division of Internal Audits in 1995.

DIVISION OF HIV COUNSELING & TESTING SERVICES

Under the AIDS Administration, reorganized as the Division of Local Prevention Services under the Center for AIDS Education in 1996.

DIVISION OF PRIMARY CARE & RURAL HEALTH

From the Policy and Health Statistics Administration, the Division was transferred to the Local and Family Health Administration and renamed the Office of Primary Care Services in July 1994.

DIVISION OF PROGRAM SERVICES

Under the Medical Care Policy Administration, Division functions were transferred to two new units—the Division of Special Populations and the Division of Waiver Programs—in December 1994.

EPIDEMIOLOGY & PREVENTION

Under the AIDS Administration, reorganized as the Center for Epidemiology in 1994.

GREAT OAKS CENTER

Formerly under the Developmental Disabilities Administration, Great Oaks Center is scheduled to close by June 30, 1996. The Center's residents will be transferred to group homes in southern and central Maryland.

HEALTH SERVICES

Under the AIDS Administration, Health Services ceased to exist in 1994 when the Administration was reorganized under a Deputy Director and the assistant directorships were eliminated.

HOSPITALS & AMBULATORY CARE PROGRAM Under the Licensing and Certification Administration, the Hospitals and Ambulatory Care Program in 1995 was divided into two programs: the Developmental Disabilities and Ambulatory Care Program, and the Hospitals and Complaint Program.

OFFICE OF CHILD HEALTH

Under the Family and Local Health Administration, the Office was merged with the Office of Children's Medical Services in 1994 to form the Office of Child Health and Children's Medical Services.

OFFICE OF CHILD HEALTH & CHILDREN'S MEDICAL SERVICES

Under the Family and Local Health Administration, renamed Office of Children's Health in 1995.

OFFICE OF CHILDREN'S MEDICAL SERVICES Under the Family and Local Health Administration, the Office was merged with the Office of Child Health in 1994 to form the Office of Child Health and Children's Medical Services.

OFFICE OF PLANNING & POLICY MANAGEMENT

Under the Deputy Secretary for Operations, the Office was renamed Office of Planning and Capital Financing in 1994.

OFFICE OF WOMEN'S HEALTH

The Office of Women's Health was formed in 1994 to support the Commission on Women's Health (Executive Order 01.01.1994.18). The Office was abolished later that year. Its functions were assigned to the Office of Planning and Capital Finance.

REGIONAL FIELD SERVICES DIVISION

Under the Alcohol and Drug Abuse Administration, renamed Treatment and Field Services Division in 1994.

STATE ADVISORY COUNCIL ON ALCOHOL & DRUG ABUSE

Formerly under the Alcohol and Drug Abuse Administration, the Council has been inactive since 1992.

TASK FORCE ON FEASIBILITY OF FUTURE CONSOLIDATION OF STATE PSYCHIATRIC HOSPITALS

The Task Force issued its report in January 1995.
