## DEFUNCT DEPARTMENTAL AGENCIES

### ADVISORY COMMISSION ON INDUSTRIALIZED BUILDING & MOBILE HOMES

Formally abolished in 1994 (Chapter 126, Acts of 1994).

### ADVISORY COUNCIL ON LANDLORD-TENANT AFFAIRS

Abolished in January 1995 (Executive Order 01.01.1995.02).

### COMMERCIAL & GOVERNMENT ASSISTANCE PROGRAMS

Formerly under the Division of Community Assistance, Commercial and Government Assistance Programs were abolished in 1994.

### DIVISION OF COMMUNITY ASSISTANCE

In 1996, functions of the Division were reassigned to other units.

### DIVISION OF HOUSING FINANCE

Renamed Division of Development Finance in 1995 (Chapter 115, Acts of 1995).

### GRANTS & LOANS MANAGEMENT

Formerly under the Secretary, renamed Federal Grants Management under the Division of Neighborhood Revitalization in 1996.

### HOUSING & COMMUNITY SERVICES PROGRAMS

Under the Division of Community Assistance, named Grants and Loans Management in 1994.

### HOUSING MANAGEMENT

Formerly under the Community Development Administration, functions of this office were reassigned to the Maryland Housing Fund and to Housing Development Programs in 1995.

### LEAD PAINT ABATEMENT PROGRAM

Formerly under the Division of Housing Finance, the Program was abolished in 1995 (Chapter 335, Acts of 1995). That same year, it was replaced by the Lead Hazard Reduction Loan Program.

### MARYLAND ADVISORY COUNCIL ON HISTORIC PRESERVATION

Formerly under the Office of Preservation Services, the Council has been inactive since 1994.

### OFFICE OF COMMUNITY ASSISTANCE

Formerly under Grants and Loan Management, renamed the Local Government Infrastructure Program under the Division of Development Finance in 1996.

### OFFICE OF FINANCIAL REPORTING & REVIEW

In 1996, reorganized as the Office of Financial Planning and Review.

### OFFICE OF FISCAL PLANNING

In 1996, Office functions merged with those of the Office of Financial Reporting and Review to become the Office of Financial Planning and Review.

### OFFICE OF INFORMATION SYSTEMS

Formerly under the Division of Finance and Administration, the Office was reformed in 1996 as the Division of Information Technology and Portfolio Management.

### OFFICE OF LOCAL GOVERNMENT TECHNICAL ASSISTANCE

Formerly under Commercial and Government Assistance Programs, the Office was renamed Technical Assistance in 1994.

### OFFICE OF MANAGEMENT, PLANNING, & EDUCATIONAL OUTREACH

Under the Division of Historical and Cultural Programs, renamed Office of Management and Planning in 1996.

### OFFICE OF OUTREACH & TRAINING

Formerly under Commercial and Government Assistance Programs, renamed Regional Development in 1994.

### OFFICE OF POLICY ANALYSIS & COMMISSION SUPPORT

Renamed Office of Research under the Division of Information Technology and Portfolio Management in 1996.

### OFFICE OF RESEARCH

In 1995, renamed Office of Policy Analysis and Commission Support.

### OFFICE OF SPECIAL PROJECTS

Under the Division of Community Assistance, functions of the Office were reassigned to other units of Grants and Loans Management in 1995.

### RENTAL HOUSING PROGRAMS

Under Community Development Administration, renamed Housing Development Programs in 1995.

### TECHNICAL ASSISTANCE

Formerly under the Secretary, Technical Assistance was abolished in 1996 and its functions were reassigned to other units.
