awarded. In the meantime, the printing matter which has been already done, and for which there is no contract, or price set, must be paid for at the usual rates of such work. There is now a considerable amount of printing matter accumulated, which has been ordered, but your Committee cannot order the printing of such matter until authorized by the General Assembly.

Your Committee, therefore, recommend the acceptance of the proposition of Messrs. Thompson & Co., as it will be seen the proposal for doing the printing is \$9,300 less than the cost of doing the printing work of the session of 1868, and

\$31,400 less than the session of 1867.
