Art. 5. The issues or notes, usually denominated bank notes, which it shall be lawful for the corporation to issue, shall not at any time exceed the amount of its capital stock actually paid in, and issue. no note shall be issued of a less amount or denomination than five dollars, nor of any amount intermediate between five and ten dollars; and the General Assembly may at any time restrict the five dollars. issue of such notes, both in the amount which may be issued and in the denomination of the notes.

Art. 6. The President, each Director, Cashier, and Treasurer, before he enters upon the duties of his office, shall take the following oath or affirmation, as the case may be: I do swear, or Oathofoffic'rs affirm, that I will faithfully, impartially, diligently and honestly execute the duties of agreeably to the provisions of law and the trust imposed in me, to the best of my skill and judgment.

Art. 7. The total amount of the debts which any of the said corporations shall at any time owe, exclusive of its issues, or notes usually denominated bank notes, whether by bond, bill, note or other contract, shall not exceed the amount of capital actually paid into the said bank; provided, that the money deposited in the said bank for safe keeping, shall not be considered as the debts of the bank within the provisions of this clause, unless the contracting of a greater debt shall have been previously authorized by a law of this State, and in cases of excess, the Directors under whose administration it shall happen, shall be liable for the same in their natural and private capacities, and ble. an action may, in such cases, be brought against them, or any of them, or their heirs, executors or administrators, in any Court of Record in this State by any creditor or creditors of said corpora-
