 and whereupon the said Francis by Colbr: Sent his Attorney Complaint that whereas the said Gosias the 25<sup>th</sup> day of  
 September in the year of our Lord 1689. within the Jurisdiction of this Court, in his life time, was indebted  
 to the said Francis in the sum of five thousand three hundred thirty six pounds of lawful money by a particular account  
 then in Court may appear, and the said Gosias to the said Francis in manner aforesaid being indebted did assume  
 upon himself and to the said Francis faithfully promise that he the said Gosias the said sum of five  
 thousand three hundred thirty six pounds requested to the said Francis would well and truly receive and pay, Moreover the said  
 Gosias his promise and assumption aforesaid regarding but minding the said Francis in this behalf to describe the  
 said sum of five thousand three hundred thirty six pounds not paid nor the said George and Walter Exrs as aforesaid nor any of  
 them have not paid to the damage of the said Francis of 7000. pounds of lawful money and thereof he brought his suit  
 Court & Law.
