Shew all men by these presents that we John: Koufille & Coque: Quilland both of the County of Somerset in the County aforesaid, do at the newbridge and town of our shire to be firmly and justly indebted unto the said Sir: Broerton. Knight Sheriff of the County aforesaid. In the full and just sum of five hundred pounds of good sound merchantable tobacco and Estate, due to the said Sir: Broerton, his Heirs, Executors or Lawfull Attorney to the writing payment well and truly to be made and paid, we the above bounden do bind us the said Sir: Broerton or Coque: Quilland in the whole and for the whole, jointly and severally firmly by these presents and witness our hands and seals this 6th day of September. 1690. *over and over*

The Condition of this Obligation is such that if the above bounden John: Koufille do not make his appearance before the Justices of our next County Court to be holden the second Tuesday in January next and there to answer unto Edmund: Beauchamp, in a plea of trespass on the Case. Then this Obligation to be void and of no effect, or else to remain in full force and virtue.
