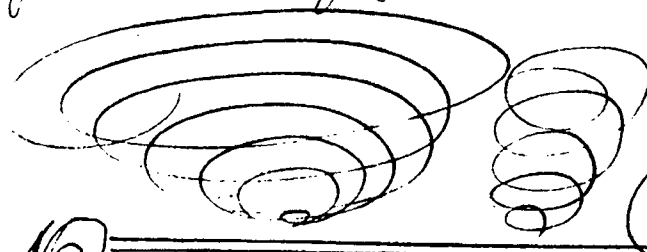

Somerset County for Thomas Cifton of this County Creditor was attached to enforce unto Henry Sabury in a plea of debt.

Thomas: Cifton. Dft

And whereas upon the p^{ts} by Edward Jones his Attorney saith that the said Thomas upon the 21st day of April and in the year of our Lord. 1682 then when became indebted unto the p^{ts} in the quantity of eight pair of good well made shees, as doth appear by a certain writing under the hand and seal of the defendt and here in Court produced but the dft. hath regarding his promise and assumption, but fraudulently intending the p^{ts} to detain in the quantity of eight pair of shees although of ten he was under required hath hitherto neglected to pay and still doth neglect to pay. whereupon the p^{ts} saith he is damaged and hath lost to the value of 12 pair of the like shees. and whereupon brings his suit.

Then was this following Bill produced and read in Court.

This Bill binds me Thomas: Cifton of the County of Somerset Creditor to pay or cause to be paid unto Henry: Sabury of the County of Somerset in the quantity of eight pair of good well made shees that is to say two pair of mowd being fall for to be delivered by what time is next ensuing the date hereof, and one pair of mowd fall to be delivered by the last of August and three pair of wouend fall and one pair of mowd fall to be delivered by the 25 of December next ensuing to the true p^{ts} hereof I bind me my Heirs, Executors, Adors or Assignes and with my hand and seal this 21. of April. 1682.
