shall be deemed and considered a public highway for ever, and as such shall be kept in repair in the same manner that other public roads in Prince George's and Anne Arundel counties respectively are.

CHAP. 140.

2. AND BE IT ENACTED, That it shall not be lawful for any Penalty for stop person to stop up, change, or in any manner obstruct, the said road, under the penalty of twenty dollars for every such offence.

1. BE IT ENACTED, by the General Assembly of Maryland, That Scheme may be Bond it shall and may be lawful for Peter Little, Daniel Conn, Basil El- to be given. der, Richard Benson, Michael Riddlemosier, Benjamin Jones, Moses Brown, John Ridgely, Thomas Gorsuch, Robert Shipley, Nathan Munro, Alexander Walters Moses Worman, John Crooks and Beale Randall, or a majority of them, to propose a scheme of a lottery for raising a sum of money, not exceeding thirty thousand dollars, clear of all expenses in drawing said lottery, and to dispose of the tickets thereof; provided the said Peter Little, Daniel Conn, Basil Elder, Richard Benson, Michael Riddlemosier, Benjamin Jones, Meses Brown, John Ridgely, Thomas Gorsuch, Robert Shipley, Nathan Munro, Alexander Walters, Moses Worman, John Crooks and Beale Randall, or a majority of them, as shall undertake to act under this law, shall, before the sale or disposal of any ticket or tickets in said lottery, give their bond to the state of Maryland, in the penalty of sixty thousand dollars, conditioned that they will well and truly apply so much of the money arising therefrom, within six months after the drawing said lottery, as will satisfy the fortunate adventurers for prizes drawn by them, and shall, within twelve months after the drawing the said lottery, apply the money raised by such lottery to the opening and completing the Baltimore and Liberty-town road.

2. And BE IT ENACTED, That it shall be the duty of the said Bond to be lodged commissioners, before they act as such, to lodge the bond entered in clerk's office. into as aforesaid in the office of the clerk of Baltimore county, there to be recorded, and upon such bond, or any office copy thereof, suit or suits may be instituted against the obligors therein, or any of them, or their legal representatives, for any breach or noncompliance with the conditions of the same.

3. AND BE IT ENACTED, That the commissioners be, and they, Authorised to sell or any person or persons appointed by them, are hereby authoris- of the state. ed, to dispose of and sell all or any of the tickets of said lottery in the city of Baltimore, or any other part of this state, exclusive of any control over the same by the corporation of the city of Baltimore, any law or usage to the contrary totwithstanding.

WHEREAS it appears to this legislature, that at the November Preamble. session of the general assembly of Maryland, in the year seven-
