Commissioners appointed to surve

1. BE IT ENACTED, by the General Assembly of Maryland, That and lay off a pub James Prather, David Cushwa and John Fight, or a majority of them, are hereby appointed commissioners to survey and lay off a public road, not exceeding thirty feet in width, beginning at the Pennsylvania line on the little cove road near to Eli William's saw mill, and thence by and through the lands of Philip Means and George Dunn, and thence to intersect the main road leading from Hager's-Town to Cumberland, near to Denton Jacques's old furnace; provided the same shall not be laid out to run over the orchard, garden or meadow, of any person, without the consent of the owners thereof, and when so surveyed and laid off, to return a plot thereof to the clerk of said county, to be there filed.

Overseer to be appointed to open said road.

2. AND BE IT ENACTED, That the levy court of said county be and is hereby empowered, at the next court thereafter, to appoint an overseer or overseers to clear and open said road, according to said plot, and to levy such sum of money as in the discretion of said court shall be considered reasonable, for the purpose of clearing and opening said road as aforesaid; and the said road, when surveyed, laid out and opened, as aforesaid, shall be deemed a public road, and shall be kept in repair as other public roads in said county are.

Al'owance to commissioners.

3. And he it enacted, That the said commissioners shall be entitled to receive, as a commensation, the sum of two dollars for every day they shall attend for the discharge of the duties required of them by this act, and the said overseer or overseers shall receive the same compensation which the overseers of public roads respectively receive, which compensation shall be respectively levied, collected and paid, in the same manner that other county charts are.
